


Letter from the Chairperson, Board of Directors

2012 was a landmark year in the 176-year history of Abingdon Square, the town square of the West Village, as the community came together to begin building a strong and sustainable foundation on which our Square is widely supported.

In March 2012, the Abingdon Square Conservancy formed its first board of directors. A series of communications and fundraising vehicles was established, including a corporate identity, fundraising and events committees, and a Web site with an e-commerce capability. Our application to the IRS to be recognized as a standalone non-profit has been filed. [Currently the Conservancy operates as non-profit under the fiscal sponsorship of the Open Space Institute (OSI).]

The Conservancy has managed its finances conservatively, which has meant that we have reduced spending, including spending on plants and gardening fees, in order to keep our budget balanced. We expect more robust fundraising in 2013 and beyond, resulting in, among other things, more plantings, greater horticultural planning and increased gardening care. In the years ahead, the newly reconstituted Conservancy will work to improve the Square by seeking to maintain our Square's structural and landscape heritage, re-greening it, providing year-round horticultural care and sponsoring the fundraising and communications programs necessary to maintain the Square for the long-term. Central to our efforts to create a lasting foundation is the development of an endowment. Please see page 5 for more information about the endowment campaign.



The Conservancy is solely dependent on private donations for its operation and receives no public funding. To continue maintaining and improving our Square, the Conservancy's donors and volunteers, as well as countless other supporters, are absolutely vital to the Square's well-being. I would be remiss if I didn't thank Lee Zimmerman, one of the founders of our park conservancy. For more than a decade, Lee dedicated himself to the Square. My fellow board members and I look forward to working together with all of the Square's stakeholders to preserve and enhance the Square, the vibrant beating heart of the West Village, for generations to come.

Letter from the Manhattan Parks Commissioner


On behalf of the Department of Parks & Recreation, I would like to congratulate the Abingdon Square Conservancy for its very impressive first year.



The Endowment Campaign

Let's Get Abingdon Squared Away

As the Conservancy's board of directors has reviewed our formative efforts in 2012, and as we look ahead, we have been evaluating what is the one initiative, that when we look back 20 years from now, will have had the greatest impact on the Square. We are unanimous that our most critical initiative is the creation of an endowment that will fund the operation of Abingdon Square for the long-term.

New York City institutions such as Central Park and the Metropolitan Opera are intended to be around for future generations and as such, require an endowment. Abingdon Square is one of the most important institutions in the West Village. It will celebrate its bicentennial in 2036 and will be around for generations to come. Our Square deserves and needs an endowment.

Currently we are supporting an institution for perpetuity on a very narrow donor base -- an annual appropriation by the boards of just three of the residential buildings adjacent to the Square and a handful of donations from neighborhood businesses and individuals. There has to be a better way.

The planned endowment and its resultant income can mean the difference between just "getting by" and the security of bringing the Square's mission and vision to life for generations to come. A strong endowment provides a secure base of resources and partially alleviates the need for raising funds on an ongoing basis for operating expenses.

The Conservancy expects to formally announce the launch of the endowment campaign later this year.



Building Community

A park is more than its physical infrastructure. Parks are places where social networks and connections are built. The Square is a key building block in fostering community cohesion in the West Village. Conservancy sponsored events in 2012 included:

October 24: Reception and Information Session






Advocacy: Removing a Pedestrian Danger and a Rodent's Paradise


The Eighth Avenue Trunk Water Main Project, part of the City's plan to upgrade the West Village's water infrastructure, was initiated by the Department of Design and Construction (DDC) in September 2012. The work has caused significant disruption, noise and dust. As part of the project, DDC built a storage area adjacent to the Square on 12th Street between 8th Avenue and Hudson Street. The storage area created blind spots for pedestrians crossing 12th Street and was a dumping ground, resulting in a rodent problem in the Square. Working with concerned community members and Speaker Quinn's office, the Conservancy was able to influence the City to move the storage area to a less heavily trafficked location. The Conservancy will continue to play an advocacy role for the West Village.


